1. Approval of October 9, 2019, minutes

- ASCCC Update (Dolores Davison)
 Dolores reported 2 resolutions regarding the baccalaureate degrees were presented during the 2019 Fall Plenary Session.
 - a. 6.01 F19 Reversal of Position Regarding Baccalaureate Degrees and Removal of Pilot Designation
 - b. 6.02 F19 Expansion of Baccalaureate Degree Programs in Allied Health reverse position , Support expansion of baccalaureate degree

Dolores also reported she and John Stanskas will be visiting legislators and advocating for the program.

3. Survey Update (Hai Hoang)

Hai reviewed the preliminary results of the survey data. Official results will be emailed at a later date. Key highlights included:

- Demographics
- College and date when baccalaureate degree was received
- Current employment status, length of time to find employment, and perception whether the bachelor's degree prepared them for employment
- Amount of student loan debt and perception regarding the value of tuition cost

4. CCBA Conference (Mike Slavich)

Mike reminded the group the Community College Baccalaureate Association (CCBA) conference is in February in Washington. There will be a workshop on workshop on articulation. Ray recommended everyone attend. He submitted a proposal "Creating an Accessible and Innovative Online Baccalaureate Degree Program in Respiratory Care for Working Professionals at Skyline College."

- CCLC Annual Convention (Mike Slavich) Mike reminded the group the CCLC Annual Convention would be held November 21 through November 23, 2019. Dolores said she would be attending.
- 6. Legislative Update (Tina Recalde)

Tina Recalde shared that Chancellor Carroll is working on legislation to ensure the baccalaureate programs are coordinated and organized; existing programs are permanent and removed from pilot status; current requirements are maintained including no duplication, evidence of workforce education needs, ACCJC/WASC and specialized accreditations are maintained as well as the same student fee structure and consultation review process. The new legislation will be launched in February after the LAO report is released.

Tina also mentioned she emailed the presentations from the October meeting.

7. Web Site (Mike Slavich)

Mike continued the discussion regarding a website for the BDP programs. He said Rio Hondo is willing to develop it and maintain it the first year.
