

Steering Committee Meeting Notes

March 17, 2021 10:00a.m.-11:00 a.m.

Roll Call

- 1. Review of minutes: February Anthony Cordova, Bakersfield College, moved to approve the minutes Jeff Gordon, Santa Monica College, seconded the motion.
- 2. ASCCC Update (Cheryl Aschenbach)

Cheryl Aschenbach reported the Senate is preparing for virtual advocacy. Four teams with three representative each met with combined 30 legislators and their staff to advocate for their four priorities. They also shared with legislators the ASCCC is concerned AB 927 does not go far enough. They [ASCCC] supports the inclusion of health and nursing where CSU is not able to meet state needs.

ASCCC leadership has also met with academic senate partners. They have received support of the bill as written and the additional components.

Additional Discussion:

Mike Slavich, Rio Hondo College asked about the CSU response. Aschenbach said there is still some concern about mission creep.

Aschenbach shared in seven of the eight meetings she attended she heard support for AB 927. She concluded encouraging BDP members continue to spread that message and support.

Shelly Hess, San Diego Mesa College, reported the minutes and agendas are being added to the website. She will also send the support letters and videos. 8. Building the Pipeline (Estella Narrie)—Area F. Ethnic Studies

Elizabeth Ramirez, Rio Hondo College, reported campuses have uploaded their course outlines of record. She encouraged faculty to upload CORs if they have not done so already.

Courses offered online, potential enrollment issues

required of students who are starting at the Community college and fall 21 or later and don't have catalog rights for previous.

Ramirez also reported students starting at the community college fall 2021 or later will be required to complete the new CSU GE pattern Area F. Ethnic Studies. She asked if this was going to be required for the BDP students. Currently colleges have been sticking closely to CSU GE and IGETC, but there is some flexibility.

Action:

Begin the conversation to determine if we are able to have flexibility with general education requirements. Specifically, determine if BDP students who start their programs fall 2021 be required to fulfill CSU GE Area F.

- 9. Legislative Update (Tina Recalde)
 - a. AB 927

Tina Recalde, San Diego Mesa College, reported the first legislative hearing is scheduled April 22, 2021. Chancellor Carroll and one other person will present. SDCCD Board of Trustees made a resolution along with testimonies. Chancellor Carroll provided an update regarding the CSU concerns.

He reported the total number of expected students, started 2018 and completed any time in 2020. He is missing data from a few colleges. He encouraged everyone to complete the form.

MiraCosta inquired about 2018—specifically, how is the data captured for a three-year graduate? They do not want to miss students who may take a little longer to complete. Hoang reported the annual data evaluation is separate from the survey. He shared: students who started 2018- and graduated 2020—cohort.

Jeff Gordon, Santa Monica College asked the members to share the strategies they are using to get a high response rate. Lisa Kamibayashi reported for the West LA—Dental Hygiene program they sent an email to students and they responded. The dental hygiene program has a strong cohort experience which facilitates survey completion rates.

Russell Reid, Feather River College, said they jumped the gun and already sent out a document. He said he is concerned sending a different survey will confuse students. Hoang and Reid strategize how to mine the date. Hoang's primary concern is consistency and data integrity. Hoang and Reid will continue discussion offline.

a. UCLA

Hoang reported, Celcilia Rios-Aguilar—civil rights project, is an advocate and would like to assist us with data analysis. She believes California community college baccalaureate programs will close the equity gap in the date. If colleges agree, Rio-Aguilar will receive raw data. FERPA rights will be maintained—no identifiable information will be released. Additionally, an MOU may be developed to ensure date integrity.

Motion:

We will share the employment data (results and de-identified raw data) of 2019 and 2020 with UCLA to support the Civil Right Project.

Discussion and questions:

- How is the data shared out?
- Most colleges expressed concerns making a decision without consulting administration;
- What additional information will be shared?
- Recommendation: provide data about the degrees, not by the colleges;
- Concerns regarding unintended consequences of sharing data;
- Support to utilize advocacy from a third-party

Next Steps:

- Hoang will send out the letter;
- College representatives will discuss the opportunity with administration;
- Hess will email an official vote—one vote per/college.
