- 3. CCCCO Update (Candice Brooks/Kimberly Cortijo)
 - a. Application Process

Candice Brooks, reported the CCCCO is in communication with CSU, UCOP, and AICCU. This is part of the inner segmental consultation piece of the legislation. They are also reviewing workforce needs of the programs submitted. They have not finalized the official approval process. Their goal is to streamline the process for the CCCCO and the colleges.

Shelly Hess asked if duplication with the CSU and UC is only for baccalaureate degrees or if it also includes certificates. Candice confirmed per the legislation duplication is only for baccalaureate degree curriculum.

Mike Slavich asked if an outside entity is reviewing the applications. Candice Brooks confirmed they are not.

Carmen Dones asked if ACCIC approval is required before colleges apply for baccalaureate degrees or after they are approved by the CCCCO. Candice Brooks said ACCIC pre-approval is not required at this time, but it may be required moving forward. Discussion continued regarding the extensive process for ACCJ Capproval. Candice Brooks requested BDP members email their concerns.

It was noted their were 10 applications during the first cycle.

b. Candice Brooks reported the CCCCO is developing a workgroup for the BDP. They are finalizing the charter document: who, what, when, why, and how. One of the primary goals is to make sure the PCAH is updated, the handbook is revised, and there is a process to review BDP programs. Additionally they are vetting a new funding model align with Ed Code and the Student Centered Funding Formula.

Questions: How do you see the groups working together to support the mission? The CCCCO will convene groups; articulation officers, etc. review additional changes such unified GE patterns, alignment with BDP. The CCCCO's roll is to help align all of the stakeholders.
