

Steering Committee Minutes October 19, 2022 10:00 a.m.-11:00 a.m.

1. Review of minutes: September Tina Recalde, San Diego Mesa College, motioned to approve.

Elizabeth Rameriz, Rio Hondo College, seconded the motion.

2. ASCCC Update (Cheryl Aschenbach)

Shelly Hess reported the following on behalf of Cheryl Aschenbach: Plenary is November 3-5. Resolution 7.02 asks field to have ASCCC "work with the California Community Colleges Chancellor's Office to incorporate the proposed lower division general education pattern for California community college baccalaureate degrees into the Baccalaureate Degree Handbook and, as appropriate, into California Code of Regulations, title 5." A table with the three GE patterns being proposed (CalGETC, AA, BDP lower division) can be found here.

3. CCCCO Update (Sean Madden)

Shelly Hess reported the following on behalf of Sean Madden: The CCCCO anticipates releasing cycle 2 applications by Friday, October 21, 2022. The CCCCO is requesting 2 pilot colleges present in a BDP training webinar on November 3 or 4.

5. CCCCEO Update (Tim McGrath)

Tim McGrath reported he attended the CCCAOE conference, there is a lot of interest throughout the field for additional legislation to allow for nursing BDPs. Discussion continued. McGrath

provided some history regarding previous efforts to allow for CCC nursing BDP programs. There is a greater need in California for nurses, especially as the number of nurses has decreased because of the number of nurses who have stepped out of the medical field since the pandemic.

McGrath also reported, plans are underway for a spring BDP workshop for current and new BDP members. The tentative dates are March 2-3; Lynn Neault is available to present for Student Services; and Golden West will host.

7. Articulation Update (Estella Narrie)

Elizabeth Ramirez reported the following information:

- The proposed GE patterns, she explained they are still going through the vetting process;
- The CCCCO BDP workgroup is working on the PCAH and the Baccalaureate Degree Handbook;
- California community colleges requested to add major articulation agreements for the BDPs into ASSIST.

Elizabeth Ramirez motioned for the BPD Committee to recognize the AO subcommittee and support adding CCC to CCC BDP articulation agreements to ASSIST.

Estella Narrie seconded the motion.

The motion was approved as presented.

8. BDP Research Update (Hai Hoang)

Hai Hoang reported he shared the draft MOU with San Diego Mesa College (SDMC) and UCLA SIE via email. Highlights of the MOU include: SDMC has agreed to provide SEIS with the following student-level data elements ("Shared Data") for past and current students enrolled in the CCB programs throughout the state of California; and CCB program includes but is not limited to gender, race/ethnicity, first-generation college student status, and students' perceptions of benefits of participation, job status, earnings, and loan selections.

Deliverables include: SEIS will provide SDMC with a report with descriptive statistics. The report will adhere to previous descriptive reports that SDMC has produced. Furthermore, SEIS will provide SDMC with the syntax created to run the descriptive analyses. Finally, SEIS will produce additional descriptive analyses (disaggregating data by zip code, loan by ethnicity, etc.) that SDMC finds valuable. SDMC and SEIS will agree on a timeline to deliver the additional descriptive analyses efforts on CCBs.

Hai Hoang shared UCLA will conduct a detailed study around three colleges. They are still in the process of identifying which three colleges they will focus on. The goal is to choose three colleges from different majors and geographic locations.

Hai reported he sent out an email sharing a link to a Google drive for college level data. Several members reported they did not receive the email. Hai will research what happened to the email.

Hai also reminded the BPD about the need for support from each college responding to surveys, sharing data, etc. This will help UCLA with their research.

Three colleges expressed interest in participating in the workshop: Bakersfield College, Solano College, and West LA.

Hai Hoang motioned to approve sending the list of the following colleges to the CCCCO and ask them to choose: Bakersfield College, Solano College, and West LA College Tina Recalde seconded the motion.

The motion was approved as presented. Shelly Hess will send the list to the CCCCO.
