1. Review of minutes: March

Mike Slavich, CCCBA, moved to approve the minutes Elizabeth Ramirez, Rio Hondo College, seconded the motion

Moorpark College and Solano College abstained.

Tony welcomed the new colleges.

3. ASCCC Update (Cheryl Aschenbach)

4. CCCCO Update (Sean Madden)

Erin Larson reported the following:

• The updated handbook is nearly complete and Chancellor's Office removed the pilot handbook from the CCCCO website:

- Assemblymember Mike Fong, D-Alhambra, and state Sen. Josh Newman, D-Fullerton asked the CCCCO to pause cycle two until issues could be resolved between the CCCCOs and CSU;
- The CCCCO does not intend to pause cycle 2;
- This information was published in Ed Source: <u>California Community Colleges moving forward</u> with bachelor's degree approval despite lawmaker objections.
- 29 applications were submitted during cycle 2, 14 applications received provisional approval;
- The CSUs and UCs have until May 12 to respond to request for duplication concerns;
- The CCCCO met with the Intersegmental Consultation Council on April 13 to discuss duplication concerns with the CSU.
- The CCCCO is ready to release Cycle 3, but they have not posted the application yet.

- Ventura College Automotive Career Education
- West Los Angeles Aviation Maintenance Technology: Avionics

Tony, speaking on behalf of the BDP steering committee, expressed his satisfaction and positive response to the California Community Colleges Chancellor's Office (CCCO) progressing with the application. He then inquired if there was any assistance the committee could offer to support the ongoing cycle.

Carmen Dones inquired if there were any concerns with the last group of programs. Erin said they have not heard any concerns at this time, they are waiting for the UCs and CSUs to finish their review.

5. CCCCIO Update

John Forbes inquired about serving this role; Tony explained the CCCCIO representative is appointed

by the CCCCIO group. Tony offered a meeting with the BDP Executive Committee to discuss the role in more detail. He also encouraged John to reach out to his constituents about committee assignments.

6. CCCCEO Update

Tony formally announced Tim McGrath formally stepped down from the committee. He expressed gratitude for Tim's leadership, commitment and dedication. The Executive Leadership Committee will reach out for another representative.

7. CCCBAUpdate (Slavich)

Slavich announced the CCCBA is aggressively seeking support for the BPD; Constance Carroll is reaching out to CEOs and CIOs to write letters of support and send them to their legislators. The group will be meeting soon.

8. Articulation Update (Estella Narrie)

Elizabeth Ramirez provided an update on the progress of the Articulation Officers regarding the development of a lower division general education pattern for California Community Colleges (CCC). She reported she presented the proposal at the Plenary and successfully garnered support for it. Furthermore, the Articulation Officers are actively collaborating with the leadership of the CCC Chancellor's Office (CCCO) and the Consultation Council in order to secure their backing for the proposal.

9. BDP Research Update (Hai Hoang)

Tony reported the following on behalf of Hai:

There is a need for increased data collection and participation in employment surveys by graduates. This data is crucial for program advocacy. However, it is noted many colleges have not yet responded to the surveys, indicating a lack of engagement. The data obtained from these surveys is extremely valuable.

Tony expressed gratitude for the support provided by the BDP members.

11. Northern California BDP Workshop (Location, Dates, times)
